5. NCFM EXAM: For capital and F & O segment, BSE CM certificates have to be passed by the franchisee or by its authorized person .Photo copies of certificates for passing these exams is required.

6. NOC from the owner of the premises where VSAT is to be installed (Form attached as Annex I)

7. Leave & Lic certificate from Franchisee/Client declaring that he/they is/are using the said place for doing business activities of share brokering, depository services etc. (Format attached as Annex II)

8. In case of Franchisee is a company or a partnership firm one person should hold 51 % share of that company/partnership firm.(As per SEBI Rules)

9. Charges for RKFML private VSAT Network shall be as stated in Annex III.

10. Technical details about VSAT network are given in Annex IV which proposed Franchisees are requested to read carefully.

TECHNICAL DETAILS FOR VSAT NETWORK

Antenna Related Information:-

KU BAND-

It is a 1.2 m Ku Band Antenna
Total space required for installation – 5 feet x 5 feet
Weight of antenna – 65 kg
Max Cable length supported – 200 feet

XC BAND-

It is a 1.4m xc band antenna
Total space required for installation – 7 feet x 6 feet
Weight of antenna 75 kg
Max cable length supported – 200 feet
It will work smoothly in bad weather also.

Minimum Hardware Required:

P- IV GHz, 256 RAM,40 GB Hard Disk,10/100 NIC LAN Card, Color Monitor, 1 Parallel Port, CD Rom Drive, Key Board, Mouse & Windows 2000,XP Pro. With latest Service Pack and Anti Virus with latest Upgrades (Everyday)

UPS Requirements:-

1. The UPS for the VSAT Equipment must be an On-line UPS
2. The UPS must be on the same earth, which is used for the VSAT ODU & IDU
3. The UPS must have an in built isolation transformer in order to keep the neutral at 0 Volts.
4. The UPS O/P and I/P should be on the same earth
5. The voltage between earth & neutral at the UPS O/P must be less than 2 Volts.
6. The voltage different points at the UPS O/P must satisfy the following relation Voltage

Between

Phase & Earth = Voltage between Phase & Neutral + Voltage between earth & neutral or P/E voltage = P/N Voltage + N/E Voltage

Damage:-

Any damage caused to the equipment at the site due to mishandling, Power Fluctuations or improper earth condition shall be borne by the sub-broker/ franchise.

Disclaimer:

Normally KU Band VSAT Perform well, however during monsoon, some places where the rain is very

heavy, the interactive traffic may be affected for sometime. But, You can get connect immediately by

your existing internet connection, ISDN, dialup etc, and after connection trading can continue uninterruptedly , for which the sub-broker or franchisee needs to have local internet connection to which

VSAT shall dial and the number shall be configured in the IDU of the VSAT.
